Athletic Grant-In-Aid Agreement

Terms of Agreement:

This Award is made in accordance with and subject to the provision of the Constitution and Bylaws of the National Collegiate Christian Athletic Association (NCCAA) pertaining to the principles of amateurism, sound academic standards, and financial aid to student-athletes. TO maintain this award, you must remain academically eligible for intercollegiate athletics. You are also required to be aware of and abide by all Grace University rules and policies.

Conditioning of Agreement

1. This award includes _____ for the academic year. This amount will be split as follows: _____ for the Fall quarter, _____ for the Winter quarter, and _____ for the Spring quarter. This amount will be credited to each quarter's tuition bill.
2. In some cases, scholarship may be stacked up to the amount of the need determined by Grace University. The total tuition discount cannot exceed the value of the university flat-rate tuition cost for 12-18 units per quarter.
3. Summer school units are not included in this agreement.
4. Your total finance assistance, including your scholarship and any other financial aid, e.g. Pell Grant and Direct Loans may not exceed the actual cost of attendance (COA).
5. Any applicable graduation or other school-related fees other than tuition are not covered in this agreement.
6. No representative of the university other than the Director of Athletics has the authority to make any commitments, present, or future, of assistance not specifically stated in this agreement. Any such commitment must be made in writing and signed by the Director of Athletics.
7. As a student-athlete, you agree and understand that you represent Grace University. Misconduct that in any way reflects unfavorably upon the university or your team is grounds

for disciplinary action, up to and including dismissal and forfeiture of the awards granted through this agreement.

8. The award granted through this agreement may be reduced or canceled in accordance with NCCAA policy if you become academically ineligible for intercollegiate competition or for serious misconduct warranting substantial disciplinary action by the Department of Athletics of by the University.
9. You must maintain a 2.0 cumulative grade point average.
10. You agree and understand that you will comply with the training regulations of the team and that you will practice at the specific times and in a diligent manner.
11. The award granted to you through this agreement may be reduced or canceled if you :
 - a. Render yourself ineligible for intercollegiate competition
 - b. Fraudulently misrepresents information on your admission application, National Lever of Intent, or this Agreement.
 - c. Engage in serious misconduct warranting substantial disciplinary penalty.
 - d. Voluntarily drop your status as a student below full time, or voluntarily withdraw from the sport for personal reasons.
 - e. The award will be prorated on a per-unit basis for part-time students.
12. This agreement must be received by the university within 30 days following the date that this agreement issued by the Director of Athletics, or this award will be considered null and void.
 - a. Students must apply to the university within the 30-day frame.
 - b. Students must apply for NCCAA clearing house within the 30-day frame.
13. You are required to maintain health insurance while enrolled at Grace University, either personally or through your family. Athletic insurance, while you are an athlete at Grace University, will be covered by the university. This coverage will be secondary to your personal or family insurance. If you do not have coverage, Covered California offers low-cost plans for students.
14. Injuries incurred while participating in intercollegiate practice or play for Grace University shall not affect this agreement.
15. You agree to participate in any drug-testing program required by the university or any applicable conferences as well as NCCAA.
16. You are required to participate in an annual College Drug Education Program for student-athletes.
17. You agree and understand that you are subject to all University policies that apply to students, including but not limited to the Student Handbook and the Student Athlete-Handbook, as well as your respective team's rules.
18. You also agree that this Grant-In-Aid agreement is private information that should not be discussed publicly with other student-athletes at Grace University. This agreement establishes an understanding between the student-athlete, coach, and Athletic Director of the amount of financial aid to be offered to the student-athlete. It also establishes the player's desire to abide by the stipulation in this contract.

In the signing of this document, you agree to all the terms listed above. You are also declaring your intent to participate with the team listed above at Grace University.
